This year, vendors will be right across from the music area in the middle of the festival area. You will be under cover, so tents are not needed. You will even have your choice of 4 sizes of vending spaces (limited availability). We can't wait to see what you have to offer! Vending procedures this year have changed, so please read carefully and follow all directions. There will be no food vending this year. The onsite restaurant will handle all food sales. Packaged food and hot beverages (i.e. Coffee, tea, etc.) will be accepted.

I hereby apply as a vendor for the Waccamaw Getaway Music Festival. The Festival will be Friday, May 27th through Sunday May 29th, 2018. Vendors will have access to the site on Friday, May 27th, beginning at 2 p.m.

Merchandise vendor fee is as follows (check space applying for):

- _____ Artist Area Space (*free of charge with restrictions. See page 2 guidelines)

Artists doing live art creation in the Artist's Area are limited to 20 participants, and if approved, this application will reserve your spot.

Standard 110 electric and water will be available to vendors. If you are selected to be a vendor, you will be asked for payment in full to reserve your spot. WGMF will let you know if you are approved by April 27th, at the latest.

If approved, you will need to bring or send a check or money order for the vendor fees. Make your check/money order out to "Get Right Promotions" and mail or deliver check to:

Vendor/Artist Guidelines

1. All vendors are responsible for liability insurance and compliance with any and all requirements of the State of South Carolina, and Horry County.
2. Any scale used for determining price will display a current legal inspection sticker.
3. All products will be displayed in a clean and safe manner.
4. Vendors are responsible for leaving their area clean at closing.
5. All vendors will be under cover. No easy up tents will be permitted.
6. Only one business per vending space, no sharing allowed.
7. Spaces shall be assigned by Festival organizers.
8. Applicable fees shall be paid in advance to secure a space, if approved.
9. Each vendor will be issued 2 weekend festival vendor passes.
10. Each vendor is expected to be open during the hours of 7 p.m. to 11 p.m. on Friday night; 11 a.m. to 11 p.m. on Saturday and Sunday. We reserve the right to revoke your passes if your space is found inactive for long periods of time.
11. Artist spaces are free and will get the artist one weekend pass, but as an artist, you are expected to spend a significant amount of time creating art. We offer the art tent for free to artists as a way to support artists and the sharing of art. Please be respectful of this by not using your pass to avoid a ticket purchase. If you are found to be using your artist pass as a way to "get in free", you may be asked to leave. You may not engage in sales of artwork unless you purchase a vendor space.
